DRAFT BYLAW 2001-291-AO
AMENDING THE ZONING BYLAW 2001-291 AND ITS AMENDMENTS

The object of this draft bylaw is to modify the zoning bylaw 2001-291 and its amendments to clarify the provisions concerning the access to a property.

DRAFT BYLAW 2001-292-I
AMENDING THE SUBDIVISION BYLAW 2001-292 AND ITS AMENDMENTS

The object of this draft bylaw is to modify the subdivision bylaw 2001-292 and its amendments to clarify the reference to the fire and civil safety regulations.

DRAFT BYLAW 2001-295-E
AMENDING THE BYLAW RESPECTING THE CONDITIONS FOR ISSUING A BUILDING PERMIT 2001-295 AND ITS AMENDMENTS

The object of this draft bylaw is to modify the bylaw respecting the conditions for issuing a building permit 2001-295 and its amendments to modify the condition with regards to being adjacent to a road.

To this effect the municipal Council will hold a public consultation meeting at the Town Hall, located at 2, rue Vale Perkins in Mansonville, **Thursday May 18th 2017**, at 4:00 p.m. in accordance with *article 125 and following the act respecting Land Use Planning*.

During the course of this meeting, the Mayor or another member of Council will explain the draft bylaws and hear every person or body wishing to express an opinion.

The proposed zoning and subdivision bylaws do not contain the provisions making them bylaws subject to approval by way of referendum.

The draft bylaws may be consulted at the Town Hall located at 2, rue Vale Perkins in Mansonville during regular business hours.
