PUBLIC NOTICE IS HERBY GIVEN TO QUALIFIED VOTERS OF THE *MYOSOTIS AND DES NÉNUPHAR* ROADS SECTOR HAVING THE RIGHT TO BE REGISTERED ON THE REFERENDUM LIST OF THE MUNICIPALITY OF THE TOWNSHIP OF POTTON

During a council meeting held on April 6, 2021, the municipal council of the Township of Potton adopted **Bylaw number 2021-475**, entitled: « *Borrowing bylaw number 2021-475 decreeing a loan in the amount of 300 000\$ to finance the upgrade repair work on Myosotis and des Nénuphars roads*».

During a council meeting held on September 7, 2021, the municipal council of the Township of Potton adopted **Bylaw number 2021-475-A**, entitled: « *Borrowing bylaw number 2021-475-A modifying the bylaw decreeing a loan in the amount of 300 000\$ to finance the upgrade repair work on Myosotis and des Nénuphars roads*».

Qualified voters in this Sector having the right to be registered on the municipality's referendum list may request that bylaws number 2021-475 and 2021-475-A become the object of a referendum by registering their name, address and quality, supported by their signature, in a register open for this purpose.

Qualified voters of the Sector wishing to register must present identification: government health insurance card, driver's licence, passport, Indian status certificate or Canadian Forces identification card.

The register will be accessible on **Thursday, September 30th, 2020, from 9:00 a.m. to 7:00 p.m.** at the town office of the Municipality of the Township of Potton located at 2, rue Vale Perkins in Mansonville.

The number of registered signatures required for Bylaws number 2021-475 and 2021-475-A to become the object of a referendum is **14**. Should this number not be reached, Bylaws number 2021-475 and 2021-475-A will be considered as approved by the qualified voters.

The results of the registration procedure will be announced at **9:00 a.m. on October 1st, 2021**, at the town office of the municipality.

The Bylaws are available for consultation at the municipal office situated at 2, rue Vale Perkins during regular business hours.

Conditions to be considered as a qualified voter having the right to be registered on the referendum list for the territory of the Municipality:

- All persons who, on April 6, 2021, are not struck with an inability to vote in virtue of article 524 of the *Municipal Elections and referendum Act* and meet the following requirements:
 - is a physical person domiciled in the municipality and having been a resident of Quebec for at least 6 months and;
 - be 18 years old or older, a Canadian citizen and not under guardianship.
- All non-resident sole owners or non-resident occupants of a business not struck with an inability to vote and who meet the following requirements:
 - be the sole owner or sole occupant of a business located in the municipality for at least 12 months;
 - in the case of a physical person, be 18 years old or older, a Canadian citizen and not under guardianship.

- All undivided non-resident co-owners or non-resident co-occupants of a business located in the municipality not struck with an inability to vote and who meet the following requirements:
 - be an undivided non-resident co-owner or non-resident co-occupant of a business located in the municipality for at least 12 months;
 - be designated, by means of a proxy signed by the majority of persons who are co-owners or co-occupants for at least 12 months, as the person with the right to sign the register in their names and be registered on the municipal referendum list if this be the case. This proxy must have been produced prior to, or at the time of, the signing of the register.
- Legal peron
 - designated by resolution, from among its members, directors or employees, a person who, on April 6, 2021 and at the time of exercising that right, is of full age and a Canadian citizen, who is not under curatorship and is not subject to no inability to vote provided by law.
